

## Troop 46 Code of Conduct

The ideals of Boy Scouting are spelled out in the Scout Oath, the Scout Law, the Scout Motto and the Scout Slogan. A Scout measures himself against these ideals and demonstrates Scout Spirit by living by these ideals and continually trying to improve by doing his best.

As a member of Troop 46, a Scout agrees to the following Code of Conduct:

- I will abide by the Scout Law, the Scout Oath, and the Outdoor Code.
- I will attempt, by my actions and deeds, to bring honor upon my troop and myself.
- I will complete my assigned duties and participate in the activities of my patrol and troop to the best of my ability.
- I will be responsible for my behavior and treat the leaders and other members of the Troop with respect, in the same manner I wish to be treated.
- I will responsibly use and care for Troop equipment and the property of the school, church and others.
- I will respect the authority of all Scout and adult leaders by:
  - Paying attention
  - Accepting and following through with directives and assignments given to me by any Patrol Leader or Scoutmaster.
  - Accepting and following through with consequences for my behavior
- I will be kind and will not hit, kick, shove or otherwise physically harm any Scout and will not haze or harass anyone in my Patrol, Troop, or any other Scout.
- I will be courteous and will not use profanity, obscene gestures, ethnic or sexual slurs, disrespectful language, or make derogatory comments towards anyone; Scout, Leader, or parent. I will not abuse my position of authority as a leader or be disrespectful to those under my leadership.
- I will respect the property of other people and not take or use any personal items that do not belong to me without permission from the owner.
- I will use matches, knives, and other cutting tools following the rules and guidelines of the Fireman's Chit and Tote-n-Chip.
- I will set a good example by wearing the appropriate Scout uniform to all Scout activities.
- While participating in Scout activities, I am expected to demonstrate Scout Spirit in my dealings with other Scouts, adult leaders, parents, and the general public. I understand that by engaging in conduct contrary to the Scout Law, Scout Oath, or other policies set forth by Troop 46, one or more of the following consequences may occur, depending on the severity of my action:
  - Verbal Counseling from the Patrol Leader and Senior Patrol Leader
  - Temporary removal from the activity and counseling from the Scoutmaster
  - A meeting with the Scout, his parents, and adult Troop Leaders to discuss the situation and to seek a solution.

I have read the Troop 46 Code of Conduct, and I agree to follow these principles in my words and deeds, to live by the Scout Law and Scout Oath, and demonstrate Scout Spirit as a member of Troop 46 and in my everyday life.
